# **Shipping:**

- We only ship online purchases with express shipping by Australia post. For purchases above \$250 this service is complimentary, for purchases below this amount we charge a \$15 postage and handling fee.

- We do not ship to third party addresses except by prior arrangement.

- Time frame for delivery between 2-7 business days depending on location (rural/metro) day purchase.
